The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 2. Review and approve the minutes of the regular meeting held on December 18, 2023, of the Board of Directors;
- 3. Bookkeeping report, including financial and investment reports, and authorizing the payment of invoices presented; report on various investment options for the District;
- 4. Adoption of Resolution Adopting List of Qualified Brokers Authorized to Engage in Investment Transactions with District;
- 5. Tax Assessor-Collector's report; authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll; authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
